1990-91 (With Aid) in Arts and Commerce Streams.

Sir,

With reference to your application dated 2-3-60 on
the subject noted above, I am directed to convey the approval
of the Director of Education, Delhi for the upgradation of
the existing Secondary School to Senior Secondary school level
with aid with effect from 1990-91 session, subject to the
fulfilment of the following terms & conditions:-

1. That the school shall abide by the provisions of
Delhi School Education Act, 1973 & Rules, framed
thereunder as well as the instructions issued from
time to time.
2. That the school shall admit students without any
discrimination of caste and creed.
3. That the school shall meet the additional liability
of Senior secondary classes.
4. That the school shall purchase adequate of Science
Equipments and apparatus as per the norms of CBSE/
Education Department for Secondary classes.
5. That a proper library shall be established and
facilities for reading-room shall also be made
available for students as well as teachers. Books
as per the ratio of 10 Books per student shall be
purchased and made available to the students.
6. That adequate sports material shall be purchased and
made available to the students.
7. That the school shall strictly abide by the provisions
of section 10(1) of the Delhi School Education Act-
Rules 1973.
8. That the school shall not run any unrecognised classes
or any non-educational activities within the school
premises and all the recognised classes shall be run
at one place at the above address only. Nursery classes
be removed from the premises of the school immediately,
if any.

9. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
10. Fresh Health Certificate from MCD be obtained and produced to Education Officer for verification.
11. The Management of the school will obtain land from DDDA, if already not obtained, in the name of the society through Directorate of Education, Delhi and shall construct a school building thereon of the school as per specifications of the department within a period of 2 Years. That adequate and sufficient accommodation of 12 sq. ft. per student shall provide for the class-room. The normal size of the class-room with 24' X 20'.
12. The Managing Committee of the school shall not increase/enhance fee during the ensuing academic session without the prior approval of Director of Education which is a mandatory requirement under sub-section (3) of section 10 of Delhi School Education Act, 1973.
13. That all the facilities prescribed under Rule 50 & 51 of the DSER, 1973 shall be made available of the students.
14. XIth class should not be added without the prior approval of the Director of Education.
15. That the management of the school shall create a Reserve Fund of Rs. 10,000-00 (Rs. Ten thousand Only).
16. That the school shall comply with the norms of the CBSE for affiliation and examination purposes.
17. That report about the fulfilment of the above conditions shall be sent to the Education Officer every six months.
